Pasadena ISD hires firm to conduct needs assessment

The Pasadena ISD Board of Trustees voted unanimously to hire IBI Group Architects for an assessment of school building and facility needs.

The assessment will be used by the Future Facilities Planning Committee to prioritize and schedule future project recommendations for the district and the board. The process will take about four to five months to complete and will cost the district a not to exceed amount of \$73,000.

"The firm will audit and evaluate PISD facilities for maintenance, renovation, building upgrade and replacement needs, in addition to providing a master plan of recommended improvements, life cycles, cost estimates, scheduling/phasing of replacement, reorganization and/or new construction needs."
